ARTICLE ONE Name.

The name of this Corporation is Bartronics Incorporated.

ARTICLE TWO Registered Agent, Principal Office and Address.

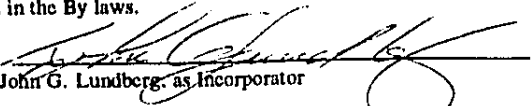

ARTICLE SEVEN Incorporator.

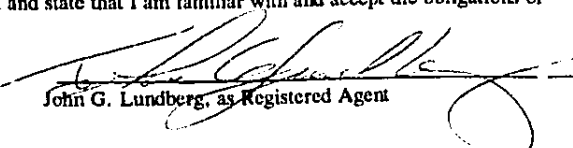
Bartronics Incorporated is incorporated by John G. Lundberg, 49 Ivan Church Road, Crawfordville, Florida 32327.
