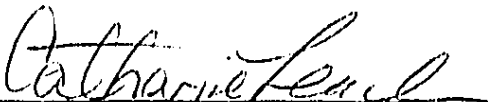
1. The name of the corporation is **HANNA CUSTOM CARPET DESIGNS INC.**

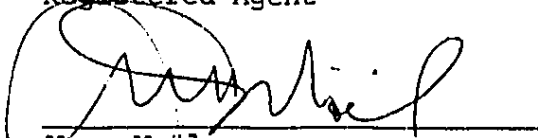
