**ARTICLES OF INCORPORATION  
OF  
P.S.A. BUILDING & PROPERTY MANAGEMENT, INC.**

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

**ARTICLE I - Name**

The name of the corporation is **P.S.A. BUILDING & PROPERTY MANAGEMENT, INC.** The principal place of business of the corporation is 580 Terminal Drive, Naples, Florida 33942. The mailing address of the corporation is 580 Terminal Drive, Naples, Florida 33942.

**ARTICLE II - Commencement and Duration**

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

**ARTICLE III - Purpose**

The corporation is organized for the purpose of transacting any and all lawful business.

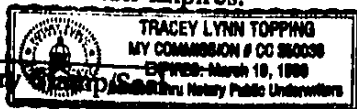


