OF

The undersigned Incorporator hereby forms and organizes a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is **DARRELL SPRADLEY CONCRETE AND CONSTRUCTION, INC.**

ARTICLE II - DURATION OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The general purposes for which this corporation is organized and the nature of the business to be transacted by it is any and all lawful activity or business permitted by the law and the corporation shall have the power and authority to do any and all things to the same extent as a natural person might or could do in any place whatsoever; including but not limited to authority to buy, sell, own, manage and

operate, trade in and deal with real and personal property of every type, kind and nature and any and all interests therein.

It is the intention of this article that the powers and nature of the business of this corporation shall not in any way be restricted or limited except by operation of law and the corporation shall have all powers as may be granted either now or hereafter to corporations by the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of stock this corporation is authorized to have outstanding at any time is 1000 shares of common stock, having a par value of \$1.00 per share, fully paid and non-accessible.

Authorized capital stock may be paid for in cash, services, or property, at a just value, but not less than par value, to be fixed by the Board of Directors of this corporation.

Every stockholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE V - REGISTERED OFFICE AND AGENT

The street address of the registered office of the corporation is Route 1, Box 418, Lake City, Florida 32055, and the mailing address of the corporation is Route 1, Box 418, Lake City, Florida 32055. The registered agent of the corporation at such office is Darrell Spradley. The registered agent, by signing these articles of incorporation, accepts appointment as such and certifies that he is familiar with and accepts the duties and responsibilities as registered agent for the corporation.

ARTICLE VI - DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time as provided in the By-Laws, but shall never be less than one (1).

ARTICLE VII - INITIAL BOARD OF DIRECTORS
