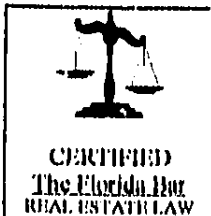

OF

**ARTICLE ONE**

The name of this corporation is Greenwerx Groundskeeping, Inc., and the mailing address of the corporation shall be 18145 Wood Drive, Fort Myers, Florida 33912.

**ARTICLE TWO**

The date of the commencement of corporate existence of the corporation shall be the date of execution of these Articles of Incorporation.

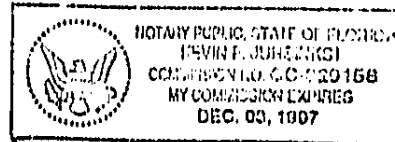

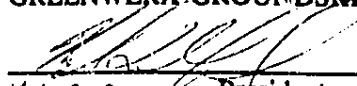
