ARTICLES OF INCORPORATION OF STUEBER-KIRK CORP.

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is STUEBER-KIRK CORP. The principal place of business of the corporation is 4745 Estero Blvd., Fort Myers Beach, Florida 33931. The mailing address of the corporation is 4745 Estero Blvd., Fort Myers Beach, Florida 33931.

ARTICLE II - Commencement and Duration

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE XI - Pre-emptive Rights
