The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is Yami Touring 96, Inc., and its address is: 233 Phoenetia Avenue, #8, Coral Gables, Florida 33134.

Duration

The duration of the corporation is perpetual.
