**ARTICLES OF INCORPORATION  
OF**

The undersigned Incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation (the "Corporation") under the laws of the State of Florida.

**ARTICLE I**

The name of the Corporation shall be:

**InvincaShield, Incorporated**

The Corporation's business shall be carried at such places in the State of Florida, the United States or foreign countries as may, from time to time, be authorized by the Board of Directors.

**ARTICLE II**

The nature of the business or businesses to be transacted by the Corporation is as follows:

The transaction of any or all lawful business for which corporations may be incorporated under Florida Statutes Section 607 et seq.

**ARTICLE III**

The maximum number of shares of stock the Corporation is authorized to have outstanding at any time shall be Ten Thousand (10,000) shares of Common Stock at No Par Value. All the aforementioned stock is to be issued as fully paid and exempt from assessment. The capital stock may be paid for in money, property, labor or services, at a just valuation to be fixed by the incorporator or by the Directors at a meeting called for such purpose.

#### **ARTICLE IV**

The Corporation shall exist perpetually.

#### **ARTICLE V**

The principal place of business of the Corporation shall be: 658 East Lake Drive, Altamonte Springs, FL 32701-5412, Florida, and may have such other places of business, both within and without the State of Florida and in foreign countries, as may be necessary and convenient.

#### **ARTICLE VI**

The business of the Corporation shall be conducted by a Board of not less than one (1) nor more than five (5) directors. The exact number of directors to be fixed by the Bylaws of the Corporation. Directors need not be stockholders.

#### **ARTICLE VII**

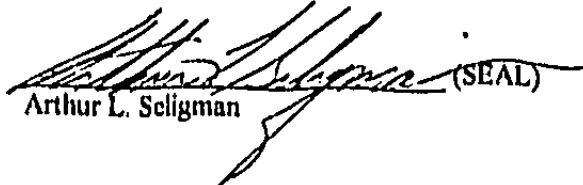

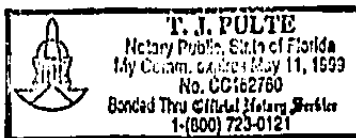

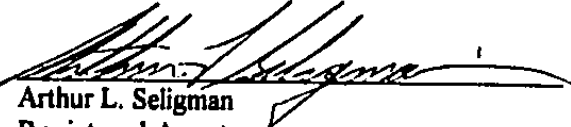
