ARTICLE I

NAME

The name of this corporation is Today's Innovative Programs, Inc.

ARTICLE II

NATURE OF BUSINESS

This corporation is organized for the purpose of engaging in and transacting any or all lawful business permitted under the laws of the State of Florida or any other state and of the United States.

ARTICLE III

PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 638 Ridgestone Court, Orange Park, Florida 32065.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue One Thousand (1,000) shares of common stock with a par value of One Cent (\$.01) per share, which shares shall be and hereby are designated as "Common Shares." 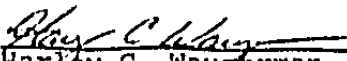

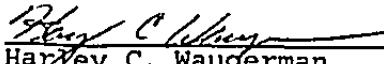
