# ARTICLE I - NAME

The name of the Corporation is BRUCE O'GRADY M.P.C., INC.

#### ARTICLE II - DURATION

The Corporation shall have perpetual existence.

### ARTICLE III - PURPOSE

The general purpose for which this corporation is being organized shall include the transaction of any or all lawful businesses for which corporations may be incorporated under Chapter 607 of the Florida Statutes now existing. or as subsequently amended, and shall include the following rights and privileges:

- A. - C. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness, and execute such mortgages, transfers of corporate property or other instruments to secure the payment of corporation indebtedness as

required.

D. To purchase the corporation assets of any other corporation and enuage in the same or other charter of business.

E. To quarantee, endorse, purchase, hold, sell, transfer, mortgage, blodge or otherwise acquire and dispose of the shares of the capital stock or any bonds, securities, or other evidence of indebtedness, created by any other corporation of the State of Florida or any other State or government and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

F.
