### ARTICLES OF INCORPORATION AMERICAN BETTER LIVING OF PLORIDA, INC.

I, TODD L. STROBEL, being of legal age do hereby authorize the formation of a corporation under the laws of the State of Florida.

IF 9-76 ARTICUE I

The name of this corporation shall be AMERICAN BETTER LIVING OF FLORIDA, INC.
