ARTICLES OF INCORPORATION  
OF  
AMERICAN BETTER LIVING OF FLORIDA, INC.

I, TODD L. STROBEL, being of legal age do hereby authorize the formation of a corporation under the laws of the State of Florida.

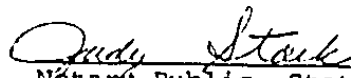
