Article I - Name

The name of this corporation shall be: FINURA CAR WASH, INC.

Article II - Duration

This corporation shall have a perpetual existence.

Article III - Purpose

This corporation is organized to engage primarily in the business of operating an automobile car wash; and for transacting any or all lawful business permitted for corporations organized under Chapter 607 of the Florida Statutes as presently in effect or as may hereafter be amended.

Article IV - Capital Stock

This corporation is authorized to issue 1,000 shares of common stock having a par value of \$1.00.




