ARTICLES OF INCORPORATION
OF
THE BUG MAN PEST SERVICES, INC.

ARTICLE I - NAME

The name of this corporation is THE BUG MAN PEST SERVICES INC.

ARTICLE II - NATURE OF BUSINESS

This corporation may engage in any activity or any business permitted under the laws of the United States of America or the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is ONE THOUSAND (1,000) shares of common stock having a nominal or par value of \$1.00 per share.

ARTICLE IV - INITIAL CAPITAL

ARTICLE V - TERM OF EXISTENCE

This corporation is to exist perpetually.
