

Pursuant to Section 607.1006 of the Florida Business Corporation Act, FUSIVE.COM, CORP., a corporation organized and existing under the laws of the State of Florida (the "Corporation"), the Articles of Incorporation of which were initially filed with the Department of State of the State of Florida on January 12, 1996, DOES HEREBY adopt the following Articles of Amendment to its Articles of Incorporation:

1. The name of this Corporation is **FUSIVE.COM, CORP.**
2. Article I of the Corporation's Articles of Incorporation is hereby amended to read as follows:

"ARTICLE I

EVISUF CORP.

The name of this Corporation is ~~INTERNET COMMUNICATION NETWORK, CORP.~~"

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
4. The Amendment hereby made to the Articles of Incorporation was duly adopted by a written consent executed by the holders of a majority of the voting power of the outstanding Series B Redeemable Participating Preferred Stock of the Corporation as of the 21st day of June, 2002, pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act. The number of votes cast was sufficient for approval of the Articles of Amendment to Articles of Incorporation.
5. The Amendment hereby made to the Articles of Incorporation was duly adopted by a written consent executed by the holders of a majority of the voting power of the outstanding common stock of, and all the members of the Board of Directors of, the Corporation as of the 21st day of June, 2002, pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act. The number of votes cast was sufficient for approval of the Articles of Amendment to Articles of Incorporation
