ARTICLES OF INCORPORATION

DIAMETERS, INC.

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

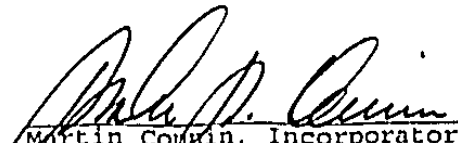

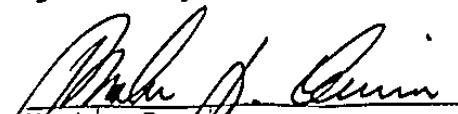
