ARTICLES OF INCORPORATION OF J & M MARKETING SERVICES, INC.

The undersigned incorporator hereby makes, subscribes to, acknowledges and files these Articles of Incorporation for the purpose of organizing and incorporating a corporation for profit uner the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be:

J & M MARKETING SERVICES, INC.

and it shall be hereinafter referred to us the "corporation".

ARTICLE II
