ARTICLES OF INCORPORATION OF  
KLEPART, INC.

I, Janette Pedraza, the undersigned, being of legal age and natural person, does hereby subscribe to, acknowledges, and files the following articles of incorporation for the purpose of creating a corporation under the laws of the state of Florida.

1. The name of this corporation shall be Klepart, Inc.
2. The purpose of this corporation shall include the transaction of any and all lawful business for which corporations may be incorporated under chapter 607, Florida Statutes.
3. The aggregate number of shares which this corporation shall be authorized to issue is one hundred (100) shares. The shares shall be issued as follows: one hundred (100) shares to Janette Pedraza, all such shares are \$.10 par value.
4. This corporation shall commence its existence immediately upon the filing of these articles of incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.
5. The address of the principal officer of the corporation and the mailing address of the corporation shall be 222 Madeira Avenue, suite 214, Coral Gables, Florida 33134. No contract or other transaction between this corporation and any other corporation, and no act of this corporation shall in any way be affected or invalidated by the fact that any of the director of this corporation are pecuniarily or otherwise interested in or is a director or officer of such other corporation. Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of this corporation, provided that the fact that she or such other firm is so interested shall be disclosed or shall have been known to the board of directors or any majority thereof, and any director of this corporation who is also a director or officer of such other corporation, or who is so interested, may be counted in determining the existence of a quorum at any meeting of the board of directors of this corporation which shall authorize any such contract or transaction with like force and effect as if she was not such director or officer of such other corporation or not so interested.

9. This corporation shall indemnify and insure its officer and director to the fullest extent permitted by law either now or hereafter.
