ARTICLES OF INCORPORATION

The undersigned persons, acting as the incorporators of GMac DEVELOPERS, INC. under the Florida Business Corporation Act, adopt the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:

GMac Developers, Inc.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The street address of the principal business office and mailing address of the corporation is:

ARTICLE III. PURPOSE

The corporation may engage in any activity and transact any and all lawful business for which a corporation may be incorporated under the Florida Business Corporation Act.

ARTICLE IV. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the fifth business day preceding the date these Articles of Incorporation are filed with the Florida Department of State.

#### ARTICLE V. CAPITAL STOCK

The number of shares of capital stock that the corporation is authorized to issue is 10,000 shares of common stock, with each share having a par value of \$1.00 per share and being entitled to one vote per share.

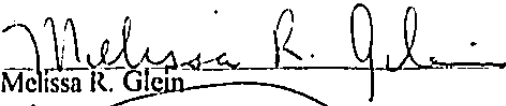

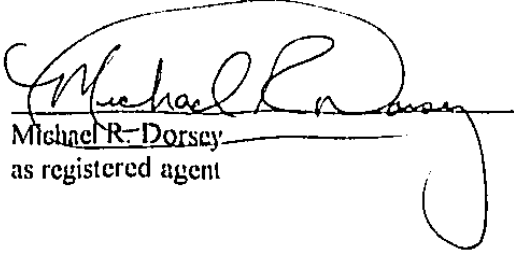
Pursuant to Sections 48 091 and 607 0501, Florida Statutes, the following is submitted:
