ARTICLE I

NAME

The name of the Corporation is MAPELP, Inc.. The principal office address and the mailing address of said Corporation is 2835 Anniston Road Jacksonville, Florida 32246.

ARTICLE II

DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III

PURPOSE


