2. That the Corporation was administratively dissolved by the Florida Department of State on September 26, 1997.

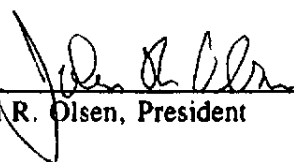
