ARTICLES OF INCORPORATION OF GERMAN-AMERICAN INFORMATION & TRADE CENTER, INC.

The undersigned hereby adopt the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE 1 - Name

The name of the corporation is GERMAN-AMERICAN INFORMATION & TRADE CENTER, INC. The principal place of business of the corporation is 3510 SE 10th Place., Cape Coral, Florida 33910. The mailing address of the corporation is the same as above.

ARTICLE II - Commencement and Duration
