The undersigned incorporators for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is Blanco, Dolan & Escalona, P.A. (hereinafter referred to as the "Corporation").

ARTICLE II - PRINCIPAL OFFICE

The initial address of the principal office of this Corporation is 1801 Coral Way, Suite 204, Miami, Florida 33145 and the initial mailing address of this Corporation shall be 1801 Coral Way, Suite 204, Miami, Florida 33145.

ARTICLE III - DURATION

This Corporation shall have perpetual existence.

ARTICLE IV - PURPOSE

The primary purpose of this Corporation is to engage in the practice of law and/or in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

The number of shares of stock that this Corporation is authorized to issue is: 350 (three hundred-fifty) and it shall

have no designated par value, The shares will be issued in the manner prescribed by the Board of Directors. Notwithstanding, anything in these Articles of Incorporation, this Corporation is authorized to issue only one class of stock and such stock shall be designated as common stock.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The name of the initial registered agent of this corporation is Grace Escalona, Esq. , upon whom process in any action or proceeding against this Corporation may be served. And the registered office is 13560 S.W. 2 St. Miami, Fl. 33184

ARTICLE VI - INITIAL BOARD OF DIRECTORS

This Corporation shall have three (3) initial Directors on the initial Board of Directors all of whom are incorporators of this Corporation.

The initial Directors on the intial Board of Directors shall remain on the intial Board of Directors until the first election of the Board of Directors to be held in the manner and at the point in time prescribed by the bylaws adopted by this Corporation as amended from time to time. The number of Directors may be increased or decreased from time to time in accordance with the bylaws adopted by this Corporation as amended from time to time. Notwithstanding anything in these Articles of Incorporation, the number of Directors on the Board of Directors shall never be less than (1). In addition to occupying the Office of the President, each initial Director on the initial Board of Directors shall occupy a second office until the first election of Officers to be held at a point in time prescribed by the bylaws of the Corporation as amended from time to time as follows:

Vice-President: Betty Blanco
Treasurer: Grace Escalona
Secretary: Susan Dolan


Additional offices may be created in accordance with the bylaws.

ARTICLE VIII - INDEMNIFICATION

This Corporation shall indemnify any Officer or Director, or former Officer or Director, to the full extent permitted by law.

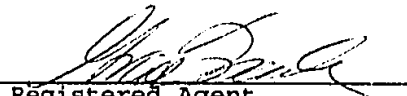
