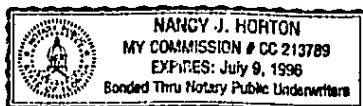

1. The name of the Florida corporation is:

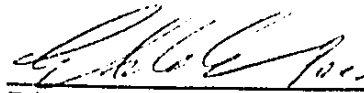
