THE NAME of this Corporation is: N. R. C. MATERIALS & SUPPLY CORP.

#### ARTICLE II. NATURE

THE GENERAL NATURE of the business to be transacted by this Corporation shall be:

**SALES OF BUILDING MATERIALS AND CONSTRUCTION SERVICES SUB-CONTRACTOR.**

- A. To engage in every aspect and phase of the business of operating a construction service and building materials sales business.

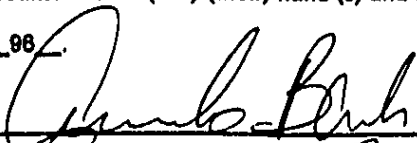
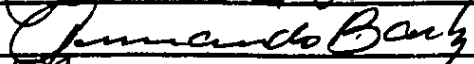

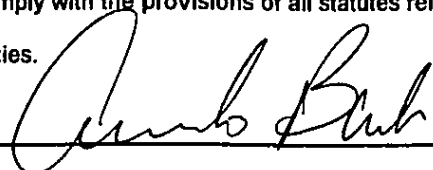
