**ARTICLE I - NAME**

The name of this corporation is MAG CONSTRUCTION, INC.

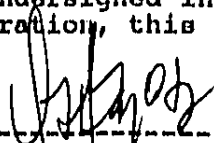
**ARTICLE VIII - BEGINNING OF CORPORATE EXISTENCE**

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors and the shareholders.

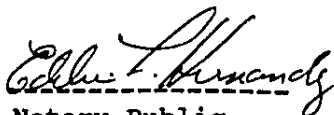
