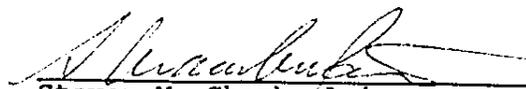

1. Name. The name of the corporation is: ENTERRA-FLORIDA, INC. 7-15-96
