# ARTICLES OF INCORPORATION OF PHILLIPS & MORRIS, P.A.

The undersigned subscribers to these Articles of ORIDA Incorporation, both natural persons competent to republished and logally authorized to practice the profession of the practice of law in the State of Florida, hereby proceed to form a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for such corporation:

## ARTICLE I. NAME

The name of this corporation is Phillips & Morris, P.A.

## ARTICLE II. PURPOSE AND NATURE OF BUSINESS

The purpose of the Corporation and the nature of its business are as follows:

- 1. To engage in the practice of law as a professional service corporation and to provide services incident thereto.
- 2. To own property, enter into contracts and carry on any activity necessary or incidental to the accomplishment or furtherance of the purpose of this Corporation.
- 3. The services of this Corporation, which consist of the practice of law shall be carried out only through officers, employees and agents who are active members in good standing of The Florida Bar, and licensed in Florida to render legal services.
- 4. ## ARTICLE III. CAPITAL STOCK

The maximum number of share of stock that the Corporation is authorized to have outstanding at any one time is 100 shares having a par value or \$1.00 per share. Such shares shall be of a single class of common stock. None of the shares of the Corporation may be issued to anyone other than an individual who is duly licensed to practice law in the State of Florida and is an active member of The Florida Bar in good standing.

# ARTICLE IV. DURATION

The Corporation shall have perpetual existence.

## ARTICLE V. ADDRESS AND AGENT

The street address of the principal and initial registered office of the Corporation is 7310 Gulf Blvd., St. Pete Beach, Florida 33706, and the name of its initial registered agent is John R. Phillips, Jr. The Board of Directors may from time to time move the office to any other address in the State of Florida and change the registered agent.

#### ARTICLE VI. DIRECTORS

The Corporation shall be managed by a Board of Directors of at least one (1) Director. No person shall serve as a Director of the Corporation unless the person is duly licensed to practice law in the State of Florida and is an active member of The Florida Bar in good standing.
