ARTICLES OF INCORPORATION OF CARE BILT, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following articles of incorporation.

ARTICLE I - NAME

The name of the corporation is Care Bilt, Inc.
