The undersigned subscribers to these Articles of Incorporation being natural persons competent to contract, hereby subscribe to and form a corporation for profit under the laws of the Sovereign State of Florida.

ARTICLE I

The name of the corporation is PROFESSIONALS DEVELOPMENT SOURCE, INC.

ARTICLE II

The corporation may engage in any and all activity or business for which corporations may be incorporated under the present laws of the State of Florida and such other activity or business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ten thousand (10,000) shares of common stock, each share having a \$1.00 par value.

ARTICLE IV

The amount of capital with which this corporation shall begin business is \$500.00.

ARTICLE V

This corporation shall have perpetual existence.

The powers of the incorporators shall terminate upon the filing of this certificate. The names and addresses for the directors until the first annual meeting of the stockholders and until their respective successors are elected and qualified shall be 1 in number and are as follows:

ARTICLE VIII

The corporation reserves the right to amend, alter, or repeal any provision contained in this Certificate of Incorporation in the manner now or hereafter prescribed by the Statutes of Florida, and all rights and powers conferred on directors and stockholders herein are granted subject to this reservation. A majority vote of all members present and entitled to vote at a duly constituted meeting called for that purpose shall be necessary to amend these Articles of Incorporation. Said majority shall be 55% of the outstanding shares.

ARTICLE IX

The board of directors is expressly authorized to make, alter, or repeal bylaws of the corporation. Action shall be by a majority of the board of directors present at any regular or special meeting called for that purpose.

ARTICLE X

All shareholders shall have pre-emptive rights to subscribe to any shares of stock of any kind to be issued in the future, and, any stock offered for sale by any existing shareholder, shall be first offered to the corporation and/or existing shareholders on an equal basis.

ARTICLE XI

The private property of the stockholders of the corporation shall not be subject to the payment of corporate debts.

ARTICLE XII

No person shall be liable to the corporation for any loss or damage suffered by it on account of any action taken or omitted to be taken by him as a director or officer of the corporation, in good faith, if such person (i) exercised or used the same degree of diligence, care and skill as ordinarily prudent man would have exercised or (ii) took, or omitted to take, such action in reliance upon advice of counsel for the corporation, or

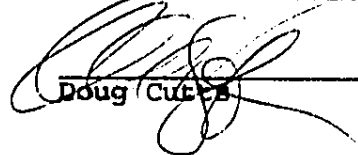
upon statements made or which he had reasonable grounds to believe to be true because they were made by officers or employees of the corporation, or were based upon financial statement of the corporation in charge of its accounts or certified by a public accountant or firm of public accountants.

ARTICLE XIII

The corporation may indemnify every person, his heirs, executors and administrators, against any and all judgments, fines, amounts paid in settlement and reasonable expenses, including attorney's fees incurred by him in connection with any clam, action, suit or proceeding (whether actual or threatened, brought by or in the right of the corporation or otherwise, civil, criminal, administrative or investigative, including appeals), to which he may be or is made a party by reason of his being or having been director or officer of the corporation or at its request, of any other corporation.

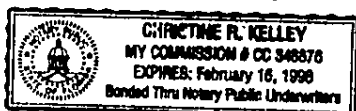
