The undersigned, acting as incorporator of a non-for-profit corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

#### ARTICLE ONE - NAME

The name of the Corporation is STONEMAN DOUGLAS MARCHING EAGLES PARENT ASSOCIATION, INC., a non-profit corporation.

## ARTICLE TWO - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

#### ARTICLE THREE - PURPOSE

- D. In the event of dissolution of the Corporation, the residual assets of the Corporation shall be transferred to one or more other organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of

1954, or to any amendments, revisions, or supplements, thereto, or to the corresponding provisions of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.
