The undersigned, acting as incorporators of a not for profit corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I

Namo

The name of the not for profit corporation shall be:
Childs Park Youth Initiative Council, Inc.

ARTICLE II

Principal Place of Business and Mailing Address

The principal place of business and the mailing address of this corporation shall be:

4719 22nd Avenue South St. Petersburg, Florida 33711

ARTICLE III

Purposes

The specific and primary purpose of the Childs Park Youth Initiative Council, Inc. is to provide youth and their families access to resources and services that will facilitate opportunities for youth development; and to promote and stimulate public interest in the education of youth and youth activities; and to establish an effective partnership between the Juvenile Welfare Board (JWB) and Public/Private Ventures (P/PV), the surrounding businesses that comprise the catalyst for economic growth and a feeling of community contribution.

It is intended that this corporation shall operate as a qualified section 501(c)(3) corporation under the Internal Revenue Codes for the purpose of providing social welfare funding to community organizations and entities to improve the educational, recreational, physical and social activities among residents of the Childs Park community in order to promote the social welfare of the community consistent with the Community Change for Youth Development Initiative; to engage in activities that will raise the standard of civic morality and community welfare; and to foster good will and mutual understanding among the members of the Childs Park Community.

ARTICLE IV

Manner of Election of Directors

The manner in which the directors are elected or appointed shall be set forth in the bylaws of the corporation.

ARTICLE V

Limitation of Corporate Powers

The not for profit corporation is authorized to exercise all powers as set forth in section 617.0302, Florida Statutes, as long as said powers are consistent with those purposes which will qualify it as an exempt organization under section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for these purposes, the making of distributions to organizations which qualify as tax exempt organizations under that Code.

This not for profit corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.
