**CHECKER FAMILY FOUNDATION, INC.**

**FIRST:** The corporate name that satisfies the requirements of section 617.0401 is CHECKER FAMILY FOUNDATION, INC.

**SECOND:** The Corporation is organized and shall be operated exclusively for religious, charitable, literary or educational purposes, as defined in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.

**THIRD:** The street address, and the mailing address, of the initial principal office of the Corporation is CHECKER FAMILY FOUNDATION, INC., c/o Hutton Ingram Yuzek Gainen Carroll & Bertolotti, 250 Park Avenue, New York, New York 10177, Attn: Paulette Kendler, Esq.

**FOURTH:** The street address of the initial registered office of the Corporation is c/o CT Corporation System, 1200 South Pine Island Road, City of Plantation, Florida 33324, and the name of its initial registered agent at such address is CT Corporation System.

**FIFTH:** This Corporation is organized under a non-stock basis.

**SIXTH:** The manner in which the directors are elected or appointed is stated in the bylaws.

**SEVENTH:** No part of the earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under section

501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future federal tax code.


