ARTICLES OF INCORPORATION

OF

NEW HONG KONG CHINESE RESTAURANT, INC.

The undersigned subscriber, a natural person competent to contract, hereby associates himself together to form a corporation under the Laws of the State of Florida, Chapter 607, and subject to the following provisions:

ARTICLE I-NAME

The name of the corporation shall be: NEW HONG KONG CHINESE RESTAURANT, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of the Articles of Incorporation.

ARTICLE III- PURPOSE

This corporation is organized for the purpose of transacting any or all lawfull business, including but not limited to:

a. Any and all lawful business.

b. Pursue its purposes and business in any and all locations

foreign and domestic.

- c. Acquire, own, hold, develop, deal in and with, maintain and operate, unlimitedly, such real and personal property of every kind and description within and without the State of Florida.
- d. Buy and sell real and personal property of any nature whatsoever.
- Convey, sell, assign, transfer, lease, mortgage, pledge, exchange or otherwise deal with any property.
