**ARTICLES OF INCORPORATION
OF
THE FLORIDA ECOTOURISM ASSOCIATION, INC.**

We, the undersigned, associate ourselves for the purpose of forming a corporation, not for profit, under Chapter 617 of the Florida Statutes:

ARTICLE I

The name of the corporation shall be:

THE FLORIDA ECOTOURISM ASSOCIATION, INC., The initial mailing address of this corporation is P.O. Box 10752, Tallahassee, Florida 32302.

ARTICLE II

DURATION

The term of existence of the corporation is perpetual and the corporate existence will commence upon the filing of these Articles by the Secretary of State.

ARTICLE III

PURPOSE

The purposes for which the corporation is organized are:

1. To promote stewardship of Florida's Natural Resources while practicing recreational and tourism uses of these resources.
2. The corporation is further organized in order to engage in any other lawful purposes not for pecuniary profits. Generally to have and exercise all rights and powers conferred by non-profit corporations under the laws of the State of Florida, or which may hereafter be conferred, including the right to contract, rent, buy, or sell personal or real

property; provided, however that this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

ARTICLE IV

INITIAL BOARD OF DIRECTORS

ARTICLE V

INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office of the Corporation shall be located at 11047 Tung Grove Road, Tallahassee, Florida 32311. The initial registered agent of the Corporation at that address will be **Paul J. Gruber**.

ARTICLE VI

DIRECTORS

The corporation shall have Directors. Directors of the Corporation will consist of persons interested in furthering purposes of the Corporation, and shall be admitted under the terms and conditions set forth in the bylaws of the Corporation.

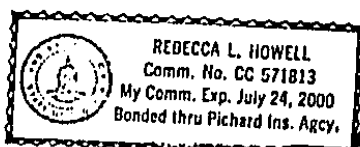
