ARTICLE I:

Parent Education With Vizcaya, Inc. is organized exclusively for (charitable and educational purposes) educating parents in parenting skills (positive discipline, responsibility, consequences, listening) a positive parenting attitude and specific drug and violence prevention strategies. All the programs use video examples, parent handbook, exercises to practice and follow up discussions and practice.

ARTICLE IV:

The Directors of the Corporation shall be appointed by the Chairman of the Board but at no time shall there be less than Three (3) Directors. Officers of the Corporation shall be elected at the annual meeting of the Board of Directors. Directors shall be appointed at the annual meeting. (Chairman of the Board and the President of the Corporation shall always be Directors)

ARTICLE V:

The Board of Directors, with the President and the Chairman of the Board shall be totally responsible for the operation of the corporation including any and all emergency.

Any officer, director, or agent may be removed by the Chairman of the Board whenever in his judgment, the best interest of the Corporation will be served thereby but such removal shall be without prejudice to the contract rights, if any of the person so removed. Election or appointment of an officer or agent shall not of itself create contract rights, and such appointment shall be terminated at will.

There are no members planned at this time only Directors. Directors cannot transfer their Directorship to anyone.

Upon the dissolution of the Corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to the Federal Government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located,

exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

There are no classes of members. There are only Directors. In order to be a Director you must be a naturalized citizen of the United States and 21 years of age. Directors of the board are appointed as previously noted.

The initial Directors are the three (3) initial members as previously listed.

Parent Educationb With Vizcaya, Inc. will be subordinate to and subject to the authority of any head or national association, fraternal or beneficial society, foundation, federation, or other corporation, society, organization, ot association not for profit.

When the bylaws are adopted by the Board of Directors they will be compatible with the Articles of Incorporation.
