**ARTICLES OF INCORPORATION
OF
THE FORT MYERS BEACH BUILD A POOL FOUNDATION, INC**

The undersigned, for the purpose of forming a nonprofit corporation under Florida Statutes Chapter 617, do hereby make and adopt the following Articles of Incorporation:

ARTICLE I. NAME AND ADDRESS OF CORPORATION

The name of the Corporation is:

ARTICLE II. NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Trustees, or Officers, except to the extent permissible.

ARTICLE III. DURATION

The duration (term) of the Corporation is perpetual.

ARTICLE IV. PURPOSES

The Corporation is organized, and shall be operated exclusively for the following purposes:

A. To raise monies for the maintenance and operation of the Fort Myers Beach Community Swimming Pool.

B. To assist city and county officials in the planning and design of the Fort

- C. To work with the City of Fort Myers Beach and Lee County Parks and Recreation in planning aquatic programs to be offered at the Community Swimming Pool.
- D. To work with the City of Fort Myers Beach in planning the daily operation of the Community Swimming Pool.
- E. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount of value, and to hold, invest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate, or otherwise dispose of such property and the income, principal, and proceeds of such property, for any of the purposes set forth herein.
- F. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE V. LIMITATIONS

No part of the net earnings of the Corporation shall inure to the benefit of or distributable to its Members, Trustees, or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV (Purposes)hereof.

ARTICLE VI. DIRECTORS

The Corporation shall have a Board of Directors whose method of election will be stated in the by-laws.

ARTICLE VII. INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VIII. OFFICERS
