## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

### ARTICLE I - NAME

The name of the corporation shall be:

The corporation shall be a non-profit organization. The general nature of the business and the purposes of the transactions to be carried out by this corporation are the same as natural persons might do to accomplish the following:

- B. To tap the potential of individuals in the physical, mental, emotional, and spiritual aspects of enhancing self-realization.
- C. To unite humanitarian, philosophical, artistic, scientific, and religious aspects of human development.
- D. To promote world peace.

#### Article IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

The positions of President, Vice President, Secretary, Treasurer, Alternate 1, and Alternate 2 are elected for two year terms following nomination by a member of the general membership, and approval by a majority vote of the members present.

In the event of temporary absence of a director, the next ranking director will fulfill the voting and administrative responsibilities of the vacant position. However, only the Vice-President may substitute for the President. The ranking order is:

1. President
2. Vice-President
3. Secretary
4. Treasurer
5. Alternate 1
6. Alternate 2

If any director is unable to fulfill a term of office, a replacement shall be elected by the members in attendance at the next general membership meeting convened for this or any other purpose.

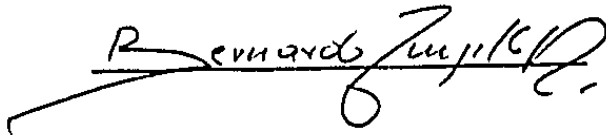
