The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

ARTICLE II

Principal place of business and mailing address

ARTICLE III

Purpose(s)

The purposes for which the Lincoln High Quarterback Club is formed are exclusively educational and charitable within the meaning of Section 501(c)(3) of the Internal Revenue Code.

ARTICLE IV

Manner of election of directors

The method of election of directors shall be as provided in the by-laws.

ARTICLE V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, except as limited herein: The Lincoln High Quarterback Club shall operate in full support of the school's football program. Notwithstanding this, or any other provision of these Articles, the Club shall not carry on any other activities not permitted to be carried on by (1) a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law or (2) corporation contributions which are deductible under Section 170(c)(2) of the

Internal Revenue Code of 1954 or any other corresponding provision of any future United States Internal Revenue Law.


