ARTICLES OF INCORPORATION

ARTICLE I-NAME

The name of this Corporation is FORUM ROMANUM, Inc. The mailing address is 28 W. Flagler St., 11th Floor, Miami, FL 33130, until such time an office location is established.

ARTICLE II-DURATION

The Corporation shall have a perpetual existence. The Corporation shall commence existence upon filing.

ARTICLE III-PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV-CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.10 per share.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The initial registered office of this corporation shall be 28 West Flagler St., 11th Floor, Miami, FL 33130, and the initial registered agent of this Corporation at such office shall be Leslie I. Snyder, who, upon accepting this designation, agrees to comply with the provisions of Section 48.091, Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process.

The number of directors may be increased or decreased from time to time by vote of the Board of Directors, but in no case shall the number of directors be less than one (1) or more than fifteen (15).
