

ARTICLES OF INCORPORATION

OF

KANAPAHA BAND BOOSTERS, INCORPORATED

ARTICLE 1

Name. The name of this Corporation is: KANAPAHA BAND BOOSTERS, INCORPORATED.

ARTICLE II

<u>Duration</u>. The Corporation shall have perpetual existence.

ARTICLE III

<u>Principal Office:</u> The principal office of the Corporation will be located at 5005 S.W. 75th Street, Gainesville, Florida 32608.

ARTICLE IV

Resident Agent and Address: The resident agent and address/registered office and agent are Joseph E. Lowry, Kanapaha Band Booster President, c/o Kanapaha Middle School, 5005 S.W. 75th Street, Gainesville, Florida 32608, and a written acceptance of said designation is appended to these Articles.

ARTICLE V

<u>Purposes</u>. The purposes for which this Corporation is formed, and the business and objects to be carried on and promoted by it, are as follows:

- (a) This Corporation is organized exclusively for charitable and/or educational purposes, including, for such purposes, the making of distributions to organizations which qualify as exempt organizations under Section 501(c) (3) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future United States Internal Revenue law.
- (b) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of its exempt purposes. No substantial part of the activities of the Corporation shall consist of the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishings or distribution of statements) any political campaign on behalf of or in opposition to any candidate for pubic office.

 Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from Federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future United States Internal Revenue law, or (2) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal

Revenue Code of 1986, as amended, or the corresponding section of any future United States internal revenue law.

ARTICLE VI

Directors:

(a) The number of Directors of the Corporation shall be at least three (3) but no more than 20 individuals. The original Directors are set forth below:

Upon the dissolution of the Corporation, all of the remaining assets of the Corporation shall be distributed only to one or more organizations created and operated for one or more exempt purposes within the meaning of Article V hereof, other than for religious purposes, all of the foregoing within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX
