I, the undersigned, hereby make, subscribe, acknowledge and file these Articles for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I

Name

The name of this corporation shall be REDISH & WOODWARD FARMS, INC.

ARTICLE II

Purpose

This corporation is organized for the purpose of growing sugar cane and for the purpose of transacting any or all lawful business.
