ARTICLE I-NAME

The name of this Corporation is STEFANI BI INTERNATIONAL, Inc. The mailing address is 28 W. Flagler St., 11th Floor, Miami, FL 33130, until such time an office location is established.

ARTICLE II-DURATION

The Corporation shall have a perpetual existence. The Corporation shall commence existence upon filing.

ARTICLE III-PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States and Florida.

ARTICLE IV-CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.10 per share.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
