ARTICLES OF INCORPORATION

OF

FOOD & BEVERAGE NEWS, INC.

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

## ARTICLE 1 - NAME AND PRINCIPAL OFFICE OF CORPORATION
