The undersigned does hereby subscribe to, acknowledge and file the following Articles of STATE Incorporation for the purpose of creating a corporation under the laws of the State of Florida, FLORIDA

ARTICLE I - NAME

The name of this corporation is North American Marketing Services, Inc.
