The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

**ARTICLE I: NAME**

The name of the corporation shall be Tillis Tutoring Center, Incorporated and the principal place of business of this corporation shall be 116 17th Street East, Palmetto, Florida 34221 and the mailing address of the corporation shall be 116 17th Street East, Palmetto, Florida 34221.



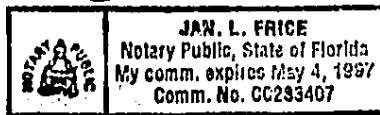

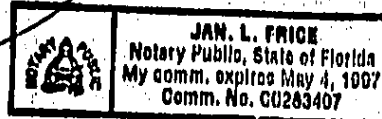
