The undersigned incorporator, for the purpose of The his Un STATE corporation under the Florida Business Corporation Act, Heroby LORIDA adopts the following Articles of Incorporation.

ARTICLE I

NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION
