ARTICLES OF INCORPORATION  
OF

ARTICLE I

Name

The name of this corporation is AERIAL IMAGING AND MAPPING SERVICES, INC.

ARTICLE II

Duration

The term for which said corporation shall exist shall be perpetual, unless sooner dissolved by law.
