The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE
NAME

The name of the Corporation is YBOR GLASS & IRON WORKS, INC.

DURATION

The duration of the Corporation is perpetual.

ARTICLE THREE
PURPOSE

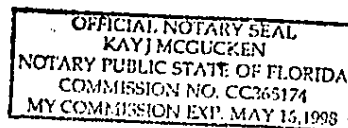
