The undersigned incorporator, for the purpose of forming a corporation pursuant to the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation, liability, rights and privileges and immunities of a corporation for profit provides:

ARTICLE I

Name of Corporation

The name of this corporation is: AMERICAN FINNISH CLUB, INC.

ARTICLE II

Purpose

The purpose of this corporation is to engage in the investment business including real estate, stocks, bonds, and small businesses or to engage in any activity or business permitted under the laws of the United States and in Florida.

ARTICLE III

Duration

This corporation shall have perpetual existence.

ARTICLE IV

Capital Stock
